Conversion Factors

Conversion factors were determined by weighting species-specific parameters by the relative species abundance within each species group for each zone. For example, the Maple species group contains several species of maples. The relative abundance of sugar maple, red maple, and other maple species within each zone was used to determine a weighted average conversion factor for that zone.

Green weights were determined by applying typical measures of specific gravity, green moisture percent, and percent wood and bark for each species. Green weights are average measures which may vary by location, site conditions, season, and other factors.
